

TERMS AND CONDITIONS FOR THE KIDS CORNER SHOW

These terms set out the terms on which Love The Beat Radio Ltd has agreed to deliver, the 'Kids Corner Show' which is detailed in the Order Confirmation.

1. INTERPRETATION

In these terms:

'**Abbreviation**' means 'Love The Beat Radio Ltd' will be abbreviated to 'LTBR'

1.1. '**LTBR**' means LOVE THE BEAT RADIO LTD (Company No. 10855832) whose registered office is at Companies House, Crown Way, Cardiff, CF14 3UZ

1.2. '**Intellectual Property**' means any and all patents, service marks, designs, utility models, unregistered or registered trade marks, business or trade names, copyright, design rights, know-how and all other similar rights of a corresponding nature;

2. CHARGES AND PAYMENT

2.1. The charges payable to LTBR for the Children's show shall be as specified in the Order Confirmation. The Buyer shall receive an E-mail with confirmation of their booking. Payment of all charges of the show is due, in clear funds, before the show start date and time.

2.2. Payment must be made to Love The Beat Radio Ltd by:

- a) Online payment via www.lovethebeatradio.com/book-online (with receipt acknowledged) to its principal place of business (or to another premises as LTBR may specify in writing); or
- b) Paypal or other electronic transfer to LTBR's bank account, as detailed on its invoice.

2.3. All charges stated in the Order Confirmation are exclusive of Value Added Tax which shall be payable in addition and at the rate from time to time in force.

3. CANCELLATION

3.1. LTBR will not be bound by a request to cancel a show thereof unless it receives written notification, by Email, Text or letter recorded delivery at least 24 hours prior to the show Start Date. If a cancellation notice is received prior to this deadline, the Buyer will receive a full refund. Cancellation notices received less than 24 hours before the show Start Date and time, regardless of when the show was booked, shall only be refunded half of the deposit. If the buyer fails to notify about a cancellation and does not attend the show, they will lose their full deposit and is no longer refundable

4. TERMINATION

4.1. LTBR may terminate any show at any time and without reason by text, email or phone with a minimum of two hours notice.

5. DATA PROTECTION

5.1. The buyer acknowledges and consents to its trading name, company name, address, and payment record being submitted to a obtain a secure booking of a show.

5.2. Unless otherwise agreed, no personal data will be transferred to the buyer by LTBR pursuant to this Agreement. The transfer of any personal data by LTBR to the Advertiser (in connection with this Campaign or otherwise) is subject to the Advertiser signing and complying with LTBR's standard data sharing agreement. Under no circumstances will personal data be transferred to the Advertiser unless the Advertiser signs such data sharing agreement and provides LTBR with confirmation that it holds a valid registration with the Information Commissioner's Office.

5.3. Each Party warrants that it shall comply with all relevant legislation and regulation governing the processing and transfer of personally identifiable data at all times. LTBR shall be the data controller of such personal data.
